RECOMMENDATION

Staff respectfully recommends that the City Council approve the attached Resolution approving the Final Map of Tract No. 74962.

BACKGROUND/ANALYSIS

On June 7, 2017, the Tentative Map for Tract No. 74962 for a proposed 50-Unit Condominium Subdivision at 124 W. Colorado Street and 203 W. Elk Avenue was approved by the Planning Commission of the City of Glendale subject to compliance with the Subdivision Map Act, other applicable State statutes, Chapters 16.32 (Final Maps) and 16.16 (New Condominiums) of Title 16 and Title 30 of the Glendale Municipal Code, as well as thirty nine (39) conditions of approval.

The conditional approval given by the Planning Commission on this Tentative Map expires on June 7, 2020, thirty-six (36) months from the date of the Planning Commission's action.

The Final Map of Tract No. 74962 is now ready for approval by the City Council. The City has received a copy of the Title Report and the Declaration of Covenants, Conditions and Restrictions establishing a Homeowner's Association, all of which are in acceptable form.

All conditions of approval of the Tentative Map have been met and the Final Map has been found by the Planning Division to be in general conformance with the Tentative Map. Accordingly, the Director of Community Development and the City Engineer recommend the approval of the Final Map.

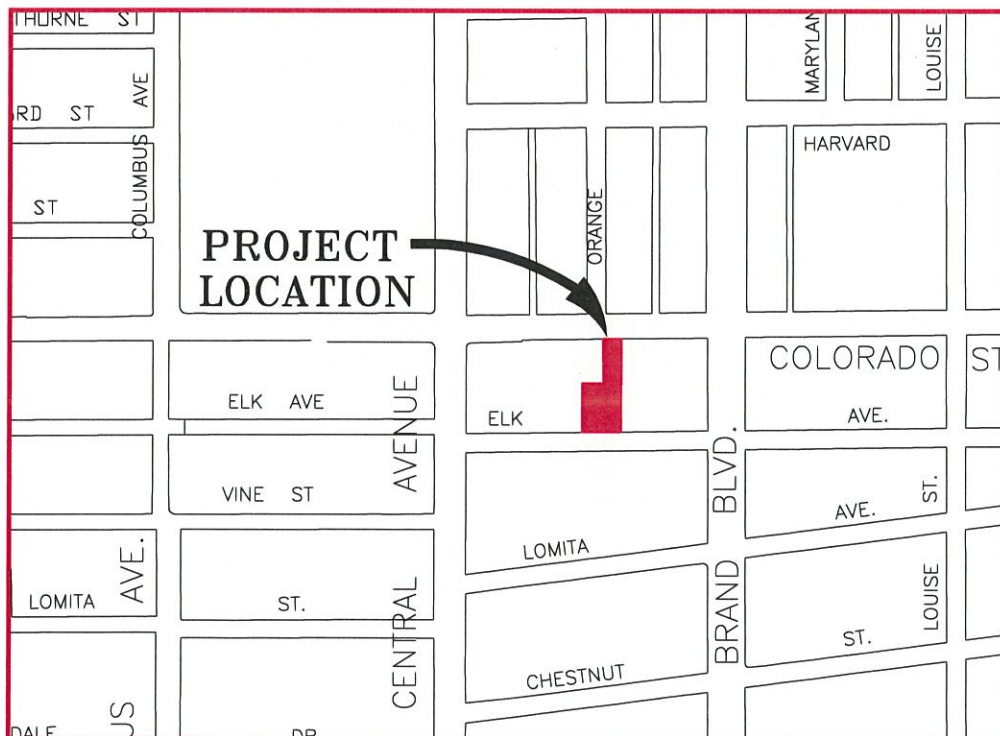
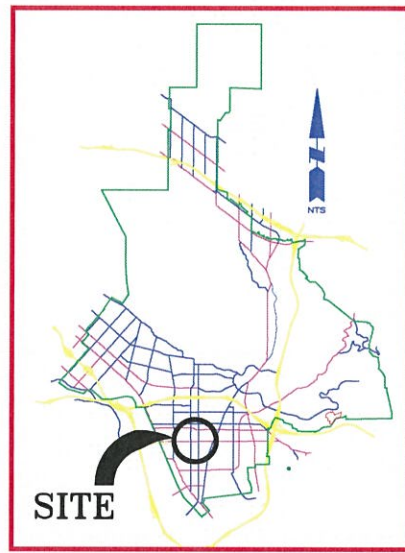
